Interview with Director Moore By Robert Welch, President Elect



On January 28, 2010, Director Ernie Moore became the Director of Ohio Department Rehabilitation and Correction. Being the first Director to achieve this position starting from the Correction Officer, members were wondering how he excelled to the heights of Director. The following is an interview conversation with Director Moore to see his insight on corrections.

You started your career as a Correction Officer in 1987. What brought you to the doors of ODRC?

I was working as a construction supervisor at the time and heard that they were building a prison in Orient, the Correction Reception Center. I was looking for job security because construction work was primarily 9 months out of the year and I would be without work 3 months in the winter. I was in the Marine Corp Reserves at the time, and I liked the idea of the paramilitary structure that came with corrections.

Myself and about 4 other good buddies (Steve Olds and Dale East are still with us) from my hometown of Sabina put in for Officer positions. We had a connection as well; Bill Thoroman was a Deputy Warden at CRC and he was also from Sabina. Growing up, me and Dale would terrorize the neighborhood where Bill's mom lived so we weren't sure it was a good thing for us that he worked there. Nevertheless it turned out ok because we were both pretty good softball players and Bill wanted to have the best team in the agency. We did well on our interview and got hired during their activation phase (before receiving inmates). Bill was a wonderful mentor and coach during those early days

You have held many titles in your career with ODRC, such as Sergeant, Lieutenant, Inspector, Administrative Assistant, Deputy Warden, Warden, Superintendant, Bureau Chief, Regional Director and Assistant Director. Which position do you think most prepared you for being Director?

The position of Warden was the position that most prepared me for the Director position. Wardens are the final decision maker for situations that take place at the prison. Also, the position of Warden is when you really begin to deal with all of the external issues surrounding prison management. It is when I really began to understand and feel the impact of the responsibilities that rested on my shoulders. Staff and inmate safety, budget issues, personnel issues, maintenance issues, community issues and on and on......



Interview with Director Moore continued:

As the first Director who rose through the ranks of ODRC, what advice would you give to an employee who one day wants to sit where you are sitting?

One of the guiding principles that I always used coming up through the ranks was that I wanted to make sure I was meeting my boss's expectations. Now over the years I have had a lot of great bosses, but I've had my share of what most folks would probably consider bad bosses here and there. Nevertheless, I learned something from every boss that I ever had. One thing that I've always strived to do was to meet their expectations. Whatever they asked me to accomplish I tried to accomplish the best I possibly could. Another piece of advice I would give is to try to expand your knowledge of our operation the best you can. You can do this through training or through outside educational opportunities. I've always strived to learn about all aspects of the DRC operation.

Maintaining a positive attitude and to staying focused on doing the right things are critical as well. Don't get into battles with people, but understand that there are going to be differences. Work your way through those differences and move on. Don't get yourself to where you have a bad attitude towards others and your work. When that occurs, you may want to start looking for another line of work. In a people business like corrections, you are going to have many disappointments, but you can't let those disappointments affect your performance or attitude. Treat others the way you would want to be treated and that includes inmates and offenders under supervision.

What is your correctional philosophy?

My correctional philosophy is that we must provide public safety through incarceration and supervision of the offenders who are sentenced to us by the courts. We also must ensure that offenders have opportunities for rehabilitation through program offerings. It is our responsibility to ensure that inmates have fair, firm and consistent supervision in an environment that is clean, safe and conducive to both public safety and rehabilitation.

Not everyone can do the jobs we do in corrections. We must display a professionalism that matches our significant responsibility in the criminal justice system.

What positive changes have you witnessed in your 23 year career with ODRC and what impact do you think those changes will have on your vision for ODRC?

The biggest positive change that I have witnessed actually resulted from the worst incident that ever happened in our agency, and that was the riot in 1993. As a result of the riot, we learned so many things and incorporated so many changes into our system that I would view as positive. The first that comes to mind is Critical Incident Management, where we now practice and have in policy actions that we would take in the event of certain incidents that could occur in our agency. I also recognize the danger and threat posed when inmates have too much information and the importance of community partnerships.



Interview with Director Moore continued:

The significant technology changes that we have experienced have been beneficial as well. Computerization and communication tools are much more advanced than when I started, all for the better.

I also want to mention that our shift to evidence based practices is a good thing in that we can analyze what we are doing to make sure our practices are effective and cost efficient.

What role did OWSA play in developing your vision and philosophy in your current position as Director?

OWSA was helpful to me because it allowed me to better realize that the Ohio Department of Rehabilitation and Correction is a national leader. I served as the President of OWSA for two years and during that tenure, we hosted the annual conference for NAAWS in Cincinnati, Ohio. That experience helped me realize the impact that an organization such as this can have on current and future leaders. Bringing professionals together from around the country to talk about common issues and trends is extremely helpful. Some of those relationships that I developed during my tenure as the President still exist today in my role as the Director.

If you had to choose one person who has inspired your career who would that be and how did they inspire you?

It is extremely difficult to choose one person because there have been so many people in my career that have inspired me, who I have watched and who I have learned from. I am referring to people like Rick Seiter, Terry Collins, Reggie Wilkinson, Tom Stickrath, Art Tate, and Bill Dallman, all folks who I watched and learned from that have been an inspiration to me. But if you forced me to pick one, it would have to be Tony Brigano. Tony Brigano was a Warden of mine back in 1989, and I learned so much from him during the five years that I served under his leadership. He took me under his wing, taught me, coached me, and he was just such an inspiration in the way that he managed people, both inmates and staff.

During last year's annual training conference, OWSA announced the creation of the Terry J. Collins Correctional Excellence Award. This award was created to recognize outstanding efforts, leadership, and commitment to excellence in Ohio's Criminal Justice System. During his decorated career in Ohio corrections, Mr. Collins exemplified all of the core values that this award represents. Fittingly, our award for excellence was named after Terry to recognize and thank him everything he has done for our membership, ODRC, and the citizens of Ohio.

From this point forward, this award will be presented annually at our training conference to an OWSA member who exemplifies excellence in the field of corrections. Nominations may be made at any time throughout the year by any active OWSA member who submits a supporting narrative to any OWSA board member. Nominations will be evaluated based on the following criteria;

- 1) Nominee must be an active OWSA member
- 2) Contributions to the field of corrections and their agency
- 3) Their role in mentoring and developing others
- 4) Community Involvement
- 5) Other factors which demonstrate Correctional Excellence

Prior to each year's conference, the board will review all nominations and make a final selection for this award. We are excited about this initiative and look forward to recognizing one of you in 2011 for the outstanding part that you play in Ohio's correctional system!

OWSA Well Represented at 2010 NAAWS: By Jay Forshey, Treasurer, OWSA


