He progressed through the supervisory ranks, and then on to Military Police Investigations and later the Criminal Investigation Division (CID) before leaving the Army. After a brief stint as a counselor with the El Paso Probation Department at the Court Residential Treatment Center in El Paso, Texas, Mark relocated back home to Ohio where he started work with the Ohio Department of Rehabilitation and Corrections as a Classification Specialist.

After holding several positions in the Ohio DRC, including unit manager, deputy warden, and regional assistant, Mark was appointed as Warden. Subsequently, he served as warden of four different Ohio prisons, and the Rusafa Prison in Baghdad, Iraq, before he retired from Ohio DRC in 2009.

Mark's first post-retirement job was with the Louisville Metro Department of Corrections in Louisville, KY, where he served as the operations administrator of the facility. He left that position for his current post as Vice President of the Nakamoto Group, Inc, where he directs the annual inspection program on behalf of the Department of Homeland Security, Immigration and Customs Enforcement, for all the facilities in the United States that house illegal immigrants.

In 2011, Mark was appointed as the Executive Director of the Ohio Wardens and Superintendents' Association, and continues to serve in that capacity as well. A graduate of the University of Texas at El Paso, Mark has served on a number of international corrections missions to destinations such as Iraq, South Africa, Germany, and Mexico. In addition to his role with OWSA, he serves and has served on a number of Boards and Committees of professional associations, including ACA, NABCJ, NCIA, NAAWS, OCCSA, and AJA. Women in Corrections



The Women in Corrections (WIC) committee was developed here at Lorain Correctional Institution as a branch of the EEO committee which focuses on issues women are faced with while working in a male dominated environment. Through education, mentorship programs, philanthropy work, and workshops, the organization assists in the development of positive self-esteem and growth on topics pertaining to women's health, finance and professionalism.

WIC recognized that sometimes the outside issues would lead to females quitting or being terminated. WIC began a conference series title "Women Empowering Women" that served as an avenue to deal directly with problems or concerns that are unique to women as well as provide the opportunity to enhance personal and professional development.

Today, WIC members continue to mentor female employees who work within the institution. They provide an open dialogue to address those "gray" areas. WIC also provides guidance; shares effective management tools, and help build confidence for female employees. WIC works hard with females to overcome obstacles in life and/or work that ultimately will help retain employment at LorCI.

The local committee also performs philanthropy work for our local stakeholders such as the Blessing House, Genesis House, Women's Heart Health, Susan G. Kolmen Breast Cancer, etc. Over the past several years our committee in conjunction with GCI & NePRC hosted conferences which grew from 75 attendees to 250. We are pulling back the reins on the conferences and getting back to what we were originally designed to do and that is to mentor women. Hosting another conference is not out of the question in the future of course!

Women in Corrections is a non-profit organization dedicated as a forum for women working in the correctional field. Through educational, mentorship programs, philanthropy work, and workshops, the organization assists in the development of positive self-esteem and growth on topics pertaining to women's health, finance and professionalism. With this support, our members can enrich their personal and professional lives while also offering assistance to local charities.

To carry out the mission of the local committee, committee members will:

Determine and carry out the charitable and educational agenda of the members of WIC; provide or conduct training conferences, programs and educational events relating to women's issues; and provide support directly and indirectly to functions and activities where charitable or educational need is demonstrated.

Empowerment includes the following, or similar, capabilities:-

- The ability to make decisions about personal/collective circumstances
- The ability to access information and resources for decision-making
- Ability to consider a range of options from which to choose (not just yes/no, either/or.)
- Ability to exercise assertiveness in collective decision making
- Having positive-thinking about the ability to make change
- Ability to learn and access skills for improving personal/collective circumstance.
- Ability to inform others' perceptions though exchange, education and engagement.
- Involving in the growth process and changes that is never ending and self-initiated
- Increasing one's positive self-image and overcoming stigma

WIC developed a one day Women's Conference titled "Women Empowering Women" that especially focused on issues directly related to women working in the field of corrections.

We believe the approach of dealing directly with issues women working in the field of corrections are faced with will assist the Ohio Department of Rehabilitation and Correction in maintaining a diverse workforce as well as increase female employee retention.

Nearly 100 attendees from Central Office, various Adult Parole Authority (APA) Regions, Northeast Pre-Release Center (NEPRC), Trumbull Correctional Institution (TCI), Grafton Correctional Institution (GCI) and LorCI gathered for a day of inspiration and motivation. Workshop presenters touched on various aspects that women working in corrections face from self esteem, stress and life balance and promoting yourself positively. Deputy Warden Kim Brown-Ware, gave a resounding lecture of hope, determination and inspired the attendees to maintain their femininity and self confidence in a male dominated environment.

The one day conference ended with an open panel discussion which included Wardens, Deputy Wardens and the 2006 Correction Officer of the Year, Karen Willingham. Positive feedback was received from conference attendees. The Lorain Correctional Institution Women In Corrections Committee is in the planning stages for this year's conference and looking forward to another successful conference.

Letter from ODRC Director, Gary Mohr



October 1, 2012

Dear Colleagues,

Over the course of the last 19 months, the Ohio Department of Rehabilitation and Correction (ODRC) has undergone significant change and we've achieved a number of noteworthy accomplishments. Our offender recidivism rate is at an all time low of 31.2%, our offender population is at low levels not seen since 2007 and we have taken significant steps toward reducing violence within our prisons. As our agency vision and mission has changed, we must change our organizational structure in order to meet the guiding principles of reducing crime in Ohio and reducing recidivism among those we touch.

Over the course of the past several weeks ODRC staff have been involved in discussions on how best to organize our agency in order to more efficiently achieve our mission. The primary focus of our re-organizational change is to create a structure that improves performance and capitalizes on the strengths of the agency. All modern organizations are faced with challenges associated with the rapidly changing environment.

Organizational leadership scholars and practitioners all agree that two primary characteristics of effective organizations are efficiency and adaptability. In our redesign, we envision the implementation of an efficient system that allows us to better prepare offenders through deconstructing the historic boundaries between prison and community supervision. The ODRC model will build a seamless continuum of supervision that begins in the institutional environment and continues into the community. We will accomplish this in part by decentralizing resources in order for management to be responsive to concerns of staff and needs of inmates, which is the mission of our unit management approach.

Decentralization of both prison and parole operations provides for creative approaches for the delivery of services and innovative problem solving. Adaptability is fostered by the implementation of new methods and technologies that guide us toward the overall mission of the agency.

Letter from ODRC Director, Gary Mohr

In Ohio, new methods have been implemented to move us toward success. One such method is the Ohio Risk Assessment System (ORAS). ORAS now guides and informs the assessment of offenders' risk and needs. Ohio is on the cutting edge in its reliance on ORAS for use in assisting decision makers in better assessing offenders' risk profiles. It will help guide staff more effectively in a manner that reduces recidivism. Over time, the use of ORAS will contribute to improvements in the use of predictive risk assessment tools, increased public safety and more successful community reentry pathways for offenders in DRC.

Another innovative approach is exemplified in the creation of the Justice Reinvestment Officer (JRO) positions within the agency. The JROs provide an example of the blended institution-community approach designed to provide a continuity of services for offenders, and effective information sharing for optimum staff supervision of offenders.

The JROs serve as liaisons between the courts and DRC. In this role, the JRO's provide credible information to the court of common pleas to identify suitable offenders for supervised release including judicial release, transitional control, and provisions within recently passed legislation designed to divert non-violent, first time offenders to more suitable community programming options. Through these and other approaches, ODRC is moving toward maximizing available resources in order to create an organizational design that eliminates the bureaucratic barriers to efficiency.

ODRC will be restructured into four regions. These regions will be developed similar to business units, fully supported with existing resources to operate. They will blend together prison operations and the Division of Parole and Community Services. This is the next logical step to truly dissolving the lines between prison and the community. Each of these regions will also include a number of satellite offices for staff. This new structure will also result in a much smaller blueprint at our Operations Support Center.

We envision that through a coordinated, structured approach to the management of the complex systems that comprise ODRC, we will reshape the organization into one well-suited for the current environment. I do not foresee this reorganization resulting in job loss; however, I do foresee the opportunity for ODRC to serve as a model for bureaucratic reorganization to ensure that we are able to accomplish our vision and mission.


